- 4. SELLER PROVIDE TO BUYER STORAGE TERMINAL CONTACT, FOR BUYER AND TANK FARM TO FINALIZE THE NUMBER OF DAYS THE BUYER WANT TO EXTEND TANK FOR DIP TEST, BUYER SEND TO SELLER CONFIRMATION EMAIL AND EXTENSION INVOICE FROM THE TANK FARM FOR SELLER VERIFICATION

TTO-TRANSACTION PROCEDURE

- 1. Buyer issues Irrevocable Corporate Purchase Order (ICPO) along with CP and Company Registration Certificate
- 2. Seller issues the MOU/TTO contract addendum for review and endorsement by both parties
- 3. Buyer obtain Legal Transshipment Ownership Certificate from the attorney in charge
- 4. Upon receipt of the Ownership Certificate with Proof of Product and Shipping documents as listed below:
 - A. Certificate of Origin
 - B. Company License to Export
 - C. Product Passport (Dip Test)
 - D. Vessel Tanker Details.
 - E. Bill of Lading
 - F. Vessel's Q88
- 5. The vessel will be re-routed to buyer's choice discharge port.
- 6. Upon arrival of the vessel at discharge Port, the vessel captain will hand over the entire original hard copy POP documents to the buyer's representative while buyer pays for the total shipment after SGS, CIQ or equivalent inspection at the discharge port via MT103.
- 7. Seller will release payments to the intermediaries involved within 48 hours of receiving the Payment for the product from the Buyer's bank
